Partial Financial Assistance for Children Going to School

Partial financial aid is available for parents/guardians who are having difficulties with sending their children to elementary or middle school for economic reasons. Funds are provided for school supplies, back-to-school necessities, class trips, school lunches, etc. Intended for:

- 1. Public aid recipients
- 2. People who have lost their public aid
- 3. Households that qualify for a municipal tax reduction or exemption
- 4. People whose income has decreased due to unemployment, illness, divorce, etc.
- People who are recognized as qualifying for public aid

How to apply: To get assistance for 2023, apply at the school using the materials provided there.

Mid-year applications are due by the end of January.

Things to Check Before Winter Comes: Don't Let Your Pipes Freeze

When the temperature hits -4°C (24.8°F) or below, your pipes might freeze or burst. Before winter is really here, ensure you know how to turn the valve that drains your pipes – get ready for cold weather well in advance.

How to Drain Pipes (for a circular valve)

- 1) Open the faucets and let any water out.
- 2) Turn the valve clockwise until it stops.

If Your Water Supply Freezes

If Your Faucets Freeze


Cover the faucet with a towel, and pour warm water over it, slowly and repeatedly. The warmth should melt the faucets.

• If the Water in Your Pipes Freezes
Remove the coldproof cap and insulating styrofoam from
the faucet column, wrap the pipes in a towel, and
repeatedly pour warm water over them.

% Hot water may damage pipes or faucets, so please use caution.

Emergency Support Funds for Resident Tax Exempt Households

In light of the soaring prices of electricity, gas, food, and other necessities, households are eligible for 50,000 years. of aid.

Eligibility: ① Households that are registered in Oshu by at least September 30th (Fri), and whose members are all resident tax exempt for FY 2022

② Households that have experienced sudden financial changes and are now eligible for resident tax exemption How to apply: ① If you got a Notification of Aid from the city, you don't need to apply. ② If you got a Confirmation Form or an Application Form, you need to apply by Tuesday, January 31st, 2023.


